To have and to hold all and singular the premises before mentioned, unto the said George A. Rankin and James C. Rankin, their Heirs and assigns forever, And we do hereby bind ourselves, our Heirs, executors, and Administrators to warrant and forever defend, all and singular the said premises unto the said George A. Rankin and James C. Rankin, their Heirs and Assigns against us and our Heirs and all others lawfully claiming or to claim the same or any part thereof through or by me, Witness our Hands and Seal this fourteenth day of December in the year of our Lord one thousand eight Hundred and seventy one and in the 96th year of the Independence of the United States of America.
